


Complaint form



About this complaint form



This is a form to make **complaints** to the **Law Enforcement Conduct Commission**.

We are called **LECC** for short.



A **complaint** is when you tell us about something you are not happy with.



We look into complaints about

- NSW Police
- NSW Crime Commission.

The **NSW Crime Commission** is a part of government that helps stop bad crime.



You can use this form to make a complaint about different things they have done.



This could be if someone from the NSW Police or NSW Crime Commission

Took money from someone they were not meant to

• Hurt you or somebody else

- Did something to stop another staff member from doing their job
- Gave secret information about the police to criminals.

A criminal is someone who breaks the law.

How to do the complaint form



There are 2 ways you can do the complaint form.



You can

• Print it

• Fill it in online.

If you print the complaint form



You can print the complaint form and then fill it.



You can ask someone you trust to help you fill it in.



You can then send us the complaint form by

Post

or

• Email.

This might be things like photos or texts on your phone.



You also do not have to tell us your real name.




You can make an **anonymous** complaint.


A **communication aid** is something that helps you talk to others.






